Background and Objectives

Starting from development priorities, the integration between development and climate objectives has received increasing attention in research and policy making over the last 2-3 years. In practice, actions are already taken for reasons such as poverty alleviation, enhancing energy security and access or improving health that have also positive climate benefits. The challenge has been to find a broadly applicable range of effective policies and actions that realise development objectives and at the same time result in real climate benefits (either reducing vulnerability to climate change impacts or development with lower emissions).

A number of projects and initiatives have aimed to identify such policies and actions. The goal of this workshop is to see what lessons for policy at the national and international level can be drawn from these experiences. It is expected that the outcomes of this workshop will provide useful contributions to sustainable development planning on issues such as poverty reduction, rural development, disaster preparedness, energy and transport as well as to the discussions at national and international level regarding next steps to deal with climate change.

The following questions will be addressed:

- What lessons can be learned from national policies that deliver positive development and climate outcomes?
- How can promising options for national/sectoral/regional policies be scaled-up through international initiatives to enhance their impact?
- How can international policy frameworks create the conditions for integrated development and climate policies?

The programme is structured around these three interconnected questions: (day 1) national strategies and policies that have development and climate benefits, (day 2) linking and scaling-up of national policies in five key development areas through international initiatives, and (day 3) international policy frameworks to create the conditions for integrated development and climate strategies outside (through mainstreaming climate in development) and inside the UNFCCC.

On *day 1* of the workshop developing country experiences that show the benefits from integrated development and climate strategies and policies will be presented and discussed. Country experiences will show synergies and trade offs between development and climate objectives, include key issues in different sectors (energy, agriculture, infrastructure) and make the link to both reducing vulnerability to climate change (adaptation) and development with lower greenhouse gas emissions (mitigation).

One of the main issues that has emerged from research and policy discussions is the importance of scaling up positive experiences with integrated development and climate actions at the project and national level. On *day 2* of the workshop a number of key development areas will be discussed in which positive development and climate outcomes are identified and where international initiatives (can) have potential to play an important role in achieving scaling-up. Break-out sessions will identify key conditions, possibilities and recommendations on how to realise both development and climate benefits for international initiatives to enhance national initiatives and policies on:

- Rural development and land use
- Disaster-management and preparedness
- Poverty reduction
- Energy security and access
- Transport

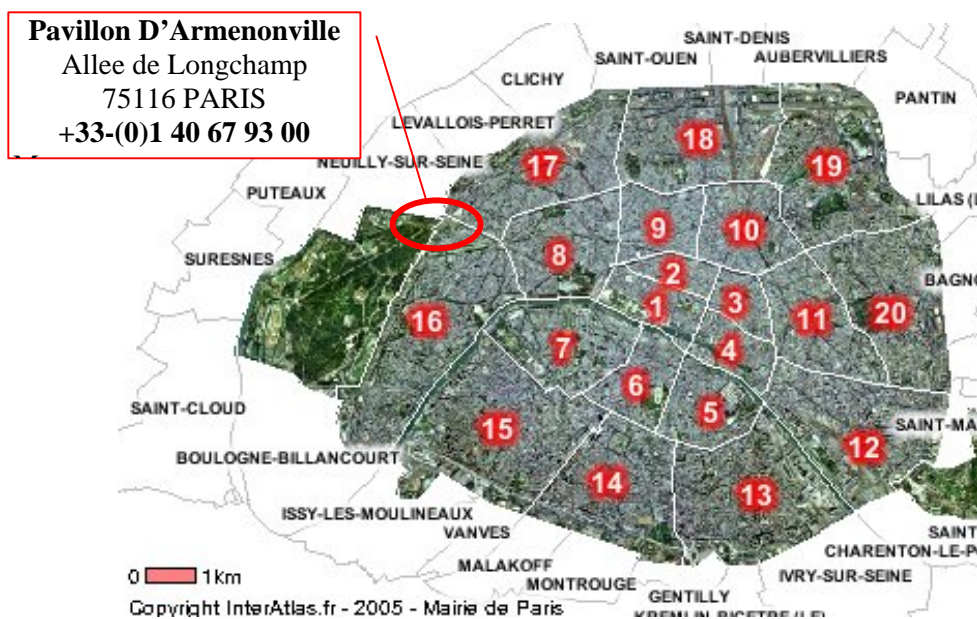
During *day 3* of the workshop the discussion will be focused on international policy frameworks that can create the conditions for integrated development and climate policies (as discussed on day 1 and 2) to be successful. Within the climate policy framework (UNFCCC) both the implementation of existing agreements in the Convention and the Kyoto Protocol, and the shaping of future agreements on which discussions are currently held, could provide incentives for integrated development and climate policies at national level. This could help to address the concerns of many countries about the tensions between addressing climate change and other urgent sustainable development priorities. Since mainstreaming climate change into other policy areas is a promising way to integrate development and climate, it also makes sense to look at non-climate policy frameworks to see what conditions they could create to encourage integrated development and climate actions at the national and international level.

Who should attend?

The workshop brings together people from the policy research community that have explored the interactions between development and climate with those that could make use of the knowledge gained. The workshop will be relevant for policy makers and stakeholders in the field of national and international development issues and for those in the climate change community who are looking for new ways to link climate change to sustainable development.
