Addressing these challenges implies renewing cooperation policies by further integrating issues of development, social and environmental sustainability and security. In the short term, this agenda is marked by a number of key events. In France, the next **DEVFLOP Interministerial Committee for International** Cooperation and Development will take place in February 2018. In Europe, the future of cooperation and development policies will be discussed in the context of the debate on the 2021-2027 Multiannual Financial Framework.

Poverty, climate, insecurity: respective and combined impact on migration – What challenges for development policies?

The goal of this session is to take stock of the linkages between, on the one hand, poverty and inequalities, political or military conflicts and the impacts of climate change and, on the other hand, the different types of migration (international migration to Europe, but also intra-regional, intra-national and commuter migration, etc.).

This particularly implies clarifying the different types of migration, the various factors causing migration, and the linkages between migration and the development of home territories and of host territories and countries. The session could also be the opportunity to discuss the importance of distinguishing between forced migration and migration as an adaptation strategy in the face of political, climate or economic shocks. It could also be useful to examine the linkages between migration and the movement of innovations.

Do security and environmental risks challenge the analysis and design of development projects?
