**László Andor** is Head of Department of Economic Policy at Corvinus University (Budapest) and Senior Fellow at the Foundation for European Progressive Studies (Brussels).

He was EU Commissioner for Employment, Social Affairs and Inclusion (2010-14). Since 2015, he has been lecturing at Hertie School of Governance (Berlin), ULB (Brussels) and Sciences Po (Paris) and became member in various think tanks (EPC, RAND Europe, Friends of Europe). He is a Policy Fellow at IZA (Bonn) and a team leader for an EFOP research project on the future of work at Corvinus. He was awarded Doctor Honoris Causa at Sofia University of National and World Economy and the Legion of Honour by the French President in 2014.

**Lucien Chabason** is Acting Director of the Institute for Sustainable Development and International Relations.

An expert on the OECD

and UNEP, he is a member of the scientific councils of the Fonds Français pour l'Environnement Mondial (French Global Environment Facility) and the Prince Albert II of Monaco Foundation.

He was coordinator of the United Nations Mediterranean Action Plan (based in Athens) from 1994 to 2003. He led the Cabinet of the French Minister of the Environment, Brice Lalonde, then prepared the national environment plan from 1988 to 1992.

He was adviser to the French Prime Minister on environmental issues from 1976 to 1978, responsible for spatial planning issues, sites and landscapes at the Ministry of Environment (1978-1984), then director of

the research department at the Ministry of Environment (1984-1988). He chaired the Plan Bleu, and founded and chaired the Association du Domaine du Rayol. He studied law, sociology and political science before attending the Ecole Nationale d'Administration (1966-1968).



**Mario Cimoli** is the Deputy Executive Secretary of the Economic Commission for Latin America and the Caribbean (ECLAC). He was

appointed in that position on August 1st, 2018. He is also Chief of the Division of Production, Productivity and Management and Officer-in-Charge of the Division of International Trade and Integration.

He is the co-chair (along with Giovanni Dosi and Joseph Stiglitz) of two of the task forces (industrial policy, and intellectual property right regimes for development) of the Initiative for Policy Dialogue at Columbia University (New York).

A PhD in economics from the University of Sussex, his research deals with development paths, economic growth and its relationship with the productive structure, and international trade.

His work examines the interconnections between industrial policy, technological development and innovation.

**Corinne Lepage** is a French politician. She served as French Minister of the Environment in the Alain Juppé cabinets I and II 1995–1997 and as Member

of the European Parliament (MEP, 2009–2014) for the North-West constituency. She is the founder and President since 1996 of the Citizenship, Action, Participation for the 21st Century Party (CAP21). She is also co-founder of the centrist Mouvement démocrate and served as Vice-President for the party until March 2010, when she announced that she was leaving the movement.

**Enrico Letta** is the Dean of the Paris School of International Affairs (PSIA) at Sciences Po and the founder of the Scuola di

Politiche in Italy.

He was the Prime Minister of Italy from April 2013 to February 2014. Before he served as Minister for EU Affairs (1998–1999), as Minister for Industry, Commerce and Crafts (January–April 2000, during the second D'Alema Government), as Minister for Industry, Commerce and Crafts and Foreign Trade (2000–2001, during the second Amato Government) and as Undersecretary of State to the Prime Minister of the centre-left government led by Romano Prodi from 2006 to 2008. Between 2001 and 2015 he was Member of the Italian Parliament, excluding between 2004 and 2006 when he was Member of the European Parliament. He graduated in International Law at the University of Pisa and obtained a PhD in European Union Law at the School for Advanced Studies "Sant'Anna" of Pisa.

**Simon Maxwell** is a development economist, who has worked internationally since 1970. He worked for ten years overseas, in Kenya, India and

Bolivia, then for fifteen years at the Institute of Development Studies, University of Sussex, latterly as Programme Manager for Poverty, Food Security and the Environment. In 1997, Simon became Director of the Overseas Development Institute, the UK's leading independent think-tank on international development and humanitarian issues. In 2009, he became a Senior Research Associate of the ODI. From 2001–5, Simon was President of the Development Studies Association of the UK and Ireland. In 2007, he was made a CBE, for services to international development. Simon Maxwell is currently the Executive Chair of the European Think Tanks Group (DIE, ECDPM, IAI, IDDRI, ODI) and a member of IDDRI's Advisory Council.

**Miguel Ángel Moratinos Cuyaubé**

Miguel Ángel Moratinos Cuyaubé was appointed by the European Union as

EU Special Representative

for the Middle East Peace Process, from 1996 to 2003. From 2004 until 2010 he was appointed Minister of Foreign Affairs and Cooperation of Spain, where he held the presidency of the United Nations Security Council and the chairmanships in-office of the Organisation for Security and Cooperation in Europe (OSCE), the Council of Europe and the Council of the European Union. From 2012 to 2013 promoted the signature of the International Treaty for a Global Dry Land Alliance (GDLA) and was member of the high-level advisory panel of

the president of the 67<sup>th</sup> Session of the UN General Assembly.

Miguel Ángel Moratinos Cuyaubé graduated in Law and Political Sciences at the University Complutense in Madrid, and then in Diplomatic Studies at the Spanish Diplomatic School. He entered Spain's diplomatic service in 1977.



A member of the European Parliament since 2014, **Alessia Mosca** is the coordinator of the International

Trade Committee for the S&D Group. Working as member of the International Trade Committee, she has been closely monitoring the negotiations between the EU and third parties—such as Canada, Vietnam, Japan and Singapore—and the trade relationship with China.

From 2008 to 2014 she was a member of the Italian Parliament, where she was appointed coordinator for the European Union Policies Committee. In 2011 she signed the so called "Golfo-Mosca" law, the Italian law 210/2011 that introduces gender quotas in the boards of listed companies. Nominated Young Global Leader (WEF) in 2009, she is a 2010 Rising Talent (Women's Forum for the Economy and Society). In 2013 she received the "World of Difference Award" of the International Alliance for Women for her merits in the promotion of female leadership and empowerment. Her activity focuses mainly on European affairs, international trade issues and gender issues.

**Karoline Postel-Vinay**, a Research Professor at Sciences Po's Center for International Research (CERI), has lectured in international politics and

East Asian affairs at Sciences Po since 1994. She has been a Research Fellow at Tokyo National University, and a visiting researcher at Waseda University and Columbia University among others.

She holds a Research Master in Japanese studies from the French National Institute of Oriental Languages and Civilizations and a PhD in International Relations from Sciences Po.

One of her work's core topics is the relation between Western and non-Western powers in international politics, and issues ranging from the dynamics of the G20, competing narratives of globalization, or Europe's normative legacy in a non-European world. Her book on the G20 (*Le G20, laboratoire d'un monde émergent*, 2011) has been translated in Spanish and English.

She was a co-leader of the EC-funded Network of Excellence on Globalization and Regionalization (GARNET) and launched the Routledge book series *Europe in the World*, and *Global Order Studies*, and has been a long-standing member of the Oxford University based Re-Thinking Europe in a Non-European World (RENEW) and other research initiatives de-centering the study of Europe.



**Ettore Recchi** is Full Professor of Sociology at Sciences Po since January 2014. He is Head of doctoral studies in Sociology.

He previously taught at the University of Chieti-Pescara, the University of Florence, the European University Institute and the University of Michigan.

He holds a PhD (with distinction) in Social and Political Sciences from the European University Institute (EUI), Fiesole, 1996.

He is also part-time professor in the Migration Policy Centre, European University Institute, Firenze.

His main research foci are mobility (in its different forms), social stratification, elites, and European integration. Currently he is coordinating a study on the influence of 'personal geographies' on attitudes and life chances (the Space-Set project).




**Cornelia Woll** is professor of political science and a researcher at the Centre for European Studies and Comparative Politics at Sciences Po. Her research

focuses on the international political economy, in particular regulatory issues in Europe and the United States. A specialist on business-government relations, she has published a book on bank bailouts in the recent crisis and one on service trade negotiations. Other work has examined economic patriotism, trade and industrial policies, Europeanization and employers' organizations.

She currently holds the Alfred Grosser Chair dedicated to the "Future of Europe" at the University of Frankfurt. Previously, she has served as Vice President for Studies and Academic Affairs (2015-18) and as Associate Dean for Research (2008-12) of Sciences Po. She was the founding co-director of the Max Planck Sciences Po Center (MaxPo) and of the Interdisciplinary Research Center for the Evaluation of Public Policies (LIEPP).

She is a graduate of the University of Chicago, holds a doctorate from Sciences Po and the University of Cologne, a habilitation from the University of Bremen and has spent a sabbatical at Harvard University.
